PARENT-CHILD REGISTRATION and CONTRACT

Birth to Three Parenting classes at Acorn Hill provide a supportive structure that builds and bridges the family experience before the child is ready for an independent school experience. Parent-Child classes are for children 2 to 3 years old with their parent or caregiver. Classes will have a minimum of 4 and a maximum of 10 parent participants. This class is one day per week, **Thursdays, from 9:15 to 11:30am**, and runs September 14 through June 7, a total of 34 weeks plus 8 parent-only evenings. **A Friday class begins in January, 2018 (spring semester).**

Full year: Sept 14 – June 7, 34 weeks, 8 parent-only evenings

Fall semester: Sept 14 – Dec 21, 13 weeks, 3 parent-only evenings

Spring semester: Jan 11 – June 7, 21 weeks, 5 parent-only evenings

To register, please complete this form and send with your check payable to Acorn Hill for the deposit indicated below. The remainder of the tuition will be billed in installments of \$269.50 monthly according to the payment schedule on reverse. Class size is limited and early registration is recommended. There will be no refunds for days missed. Diversity Fund and Tuition Assistance applications may be submitted to us for grant award consideration.

CONTRACT PROVISIONS

1. The deposit for each child is payable upon registration and holds your enrollment until the start of class. In the event a child is withdrawn before the start of classes, 50% of the deposit is withheld.
2. Tuition is payable in installments of \$269.50 for all classes. All payments are due on or before the first of each month.
3. The following payment schedules apply:

4. If space allows, switching from Fall semester to Full program must be made by October 31 to receive the Full program rates.
5. Tuition for late or mid-year enrollment will be prorated and a tuition adjustment will be due with the contract to bring the billing in line with the remaining monthly installments.
6. Any grants awarded by us will reduce your annual/semester tuition and will be credited equally against the installment payments.
7. There are no tuition credits for missed classes and no tuition transfers for switched attendance days.
8. Tuition installments that remain unpaid after the 10th of the month in which they are due are subject to a late fee of \$25 per enrollment. After 30 days, overdue tuitions are subject to collection action with reasonable court and legal fees assessed to delinquent accounts.
9. Accounts subject to collection will be assessed interest on overdue balances at the Maryland statutory rate or 12% annually, whichever is less. Payments on past-due accounts are applied first to late fees, interest and collection fees and then to the oldest outstanding balances.
10. For accounts more than 30 days past due, alternative payment plans may be agreed upon with the Finance Officer. Without such a good-faith plan established, parents will be required to keep children home.
11. If a child is withdrawn from the program during the school year from Acorn Hill for any reason, a 30 day written notice is required and contracted tuition will be prorated to the last date of attendance plus a 30 day cancellation fee.
